

# Liquivida Aventura Influencer Collaboration Agreement

This Influencer Collaboration Agreement outlines the terms between Liquivida Aventura (“Company”) and the influencer (“Influencer”).

## 1. Collaboration Overview

Influencer will receive services at a significantly reduced cost or no cost, which may include:

- Signature facial
- IV therapy
- One month of peptides or GLP1 (if medically approved)
- Any additional services agreed in writing

In exchange, Influencer agrees to create, deliver, and post content promoting the Company.

## 2. Required Deliverables

Influencer agrees to produce and deliver:

- One Instagram Reel showcasing their Liquivida Aventura experience
- One Instagram Story mentioning and tagging the Company
- A collaboration tag on the Reel so it appears on both accounts
- Full edited video file(s) delivered to the Company
- Optional additional photos or clips if requested

All content must be delivered by deadline and posted within seven days of receiving services.

## 3. Posting Guidelines

All content must:

- Tag **@liquivida\_ventura**
- Link or tag: [https://www.instagram.com/liquivida\\_ventura](https://www.instagram.com/liquivida_ventura)
- Clearly disclose partnership status
- Avoid medical claims or guarantees

- Follow platform rules and advertising guidelines
- Accurately represent the service and experience

One revision may be requested if content does not meet brand or compliance standards.

## **4. Edited Content Delivery**

Influencer agrees to deliver all edited files within twenty four hours of posting.

Delivery options include email, AirDrop, Google Drive, Dropbox, or any mutually agreed method.

---

## **5. Usage Rights**

Influencer grants the Company non-exclusive, royalty-free, worldwide rights to use, repost, edit, and repurpose all content across:

- Instagram
- Facebook
- Website
- Paid ads
- Printed materials
- In-clinic displays
- Future campaigns

Rights are granted in perpetuity.

---

## **6. Compensation**

Influencer receives complimentary or reduced-cost services in exchange for completed posts and deliverables.

No additional monetary payment is owed unless separately agreed.

---

## **7. Optional Additional Compensation Through Affiliate Program**

Influencer may opt into the Liquivida Affiliate Program for additional ongoing commissions.

Affiliate terms:

- Clients referred by Influencer receive **10 percent off** their service
- Influencer earns **5 percent commission** on the total amount paid by the referred client
- Commission is issued as in-clinic credit unless otherwise agreed

Influencer may request enrollment at any time.

---

## 8. Performance Requirements

Influencer must fulfill all posting and delivery requirements by the agreed deadlines.

Content must remain live for at least thirty days unless approved otherwise.

---

## 9. Cancellation, No-Show, and Non-Delivery

If services are received and deliverables are not completed:

- Company may invoice Influencer for the full retail value of services
  - Future collaborations may be declined
- 

## 10. Exclusivity (Optional)

Influencer agrees to avoid promoting competing med spas, IV clinics, or wellness injection clinics for seven days following collaboration unless approved.

## 11. Confidentiality and Compliance

Influencer agrees to maintain confidentiality of non-public Company information and comply with all advertising, medical, and FTC guidelines.

---

## 12. Term and Termination

Agreement begins upon signing and ends once all services and deliverables are complete. Company may terminate immediately for non-performance, misrepresentation, or reputational harm.

---

### **13. Independent Contractor Status**

Influencer is an independent contractor, not an employee, partner, or agent of the Company.

---

### **14. Liability**

Company is not responsible for any loss, injury, or damages related to the creation, posting, or performance of content.

Influencer is responsible for compliance with platform rules and disclosure laws.
